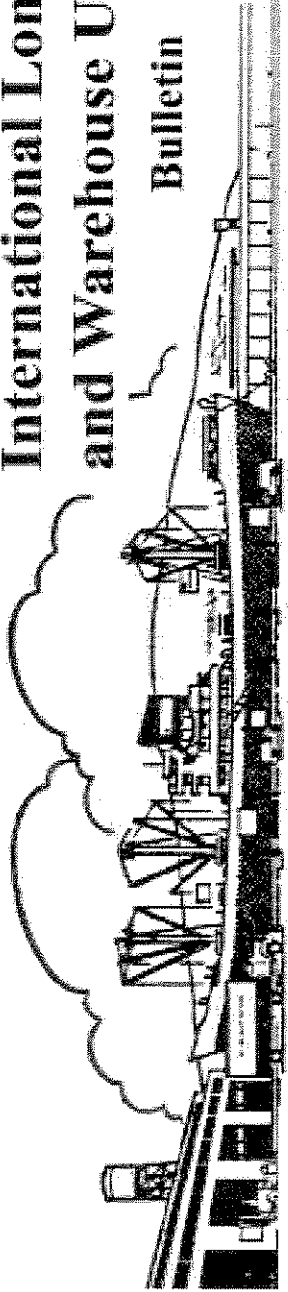

ARBITRATOR'S DECISION ON YOUR PAYROLL SHORTAGES

A hearing was held on Monday, May 21, 2007 regarding improper payroll payments as it pertains to Longshoremen's weekly shortages (SCAA-0015-2007). It was the decision of the Area Arbitrator that:

1. The PMA and MTC are found guilty of violating Section 18, The Good Faith Guarantee of the PCLCD and all sections that refer to appropriate rates of day.
2. The PMA and MTC shall make every correctly submitted (by 3:00 p.m.) shortage of eight (8) hours or more payable to each worker by 5:00 p.m. as in the past, by either an appropriate PMA check or by automatic deposit. In regards to automatic deposit such worker must be a participant in the PMA Direct Deposit Program. The above order shall begin on June 1, 2007
3. The Union's request for a 10% penalty on monies owed is denied.
4. The Union's request for an additional records clerk is denied.
