### OFFICES OF LOCAL 13 CLOSED VETERAN'S DAY

The Offices of Local 13 will be closed on Monday, November 12, 2007 in observance of Veteran's Day.

### VETERAN'S DAY PAID HOLIDAY

Veteran's Day, Sunday, November 11<sup>th</sup>, is a paid holiday. Only registered people who have 800 qualifying hours in the prior payroll year (2006) and who meet the availability requirements for at least two of the five days (exclusive of the day of the holiday) Monday through Friday will receive a paid holiday for Veteran's Day. This means that you must work or meet the availability requirements for at least two days, Tuesday, November 13<sup>th</sup>, Wednesday, November 14<sup>th</sup>, Thursday, November 15<sup>th</sup>, and Friday, November 16<sup>th</sup>, 2007.

As per the contract, when a holiday falls on a Sunday, the holiday shall be observed on the following Monday. All work performed on Monday, November 12, 2007 shall be at the overtime rate. Monday, November 12, 2007 does not count as a day of availability.

Under the current Contract, one does not have to meet the availability requirements if you have worked 1300 hours in the prior year (2006) to receive the Veteran's Day holiday pay.

Anyone intending to take a vacation during the holiday week must report the vacation to the Records Clerk in the Dispatch Hall on or before Friday, November 16, 2007 in order to be paid for the holiday. Any person not receiving holiday pay because of illness, injury, or jury duty must file a claim with the Records Clerk on or before Monday, January 4, 2008.

The Veteran's Day holiday will be paid on the paycheck of November 30, 2007.

#### Holiday notes:

- To be available, means you cannot pass a job in your skill category or a Clerk job.
- Vacation must be taken Monday through Friday.

The Records Room will extend their hours on Tuesday, November 13, 2007 from 6:00 a.m. until 5:45 p.m. due to the holiday.

## CLASS "A" DELINQUENT REMINDER

Class "A" delinquent day is on the 15<sup>th</sup> of each month. If the 15<sup>th</sup> should fall on a Saturday or Sunday, delinquent day will commence on the following Monday.

The cut off time to pay your dues on the 15<sup>th</sup> of each month is 3:00 p.m. **NO EXCEPTIONS!**

**IF YOU DO NOT PAY YOUR DUES BY 3:00 P.M. ON THE 15<sup>TH</sup>, YOU WILL BE DELINQUENT AND WILL NOT BE ABLE TO WORK. EVERY FRIDAY A NEW LIST WILL BE SENT TO THE DISPATCH HALL AT 3:00 P.M. YOU WILL BE DEAD FOR THE WEEKEND AND THE FOLLOWING MONDAY UNTIL YOUR ARE CLEARED BY THE DUES OFFICE (320 GOLDEN SHORE DRIVE, SUITE 300, LONG BEACH). THIS ALSO INCLUDES MEMBERS WITH PERMITS. YOU MUST PAY BEFORE 3:00 P.M. THE DUES OFFICE OPENS AT 7:00 A.M. EVERY FRIDAY AND DELINQUENT DAY.**

## CLASS "B" REGISTRANTS

Class "B" delinquent day is at the end of every month. You must pay your I.D. fees by 3:00 p.m. on the last day of the month, or you will be placed on the non-dispatch list.
