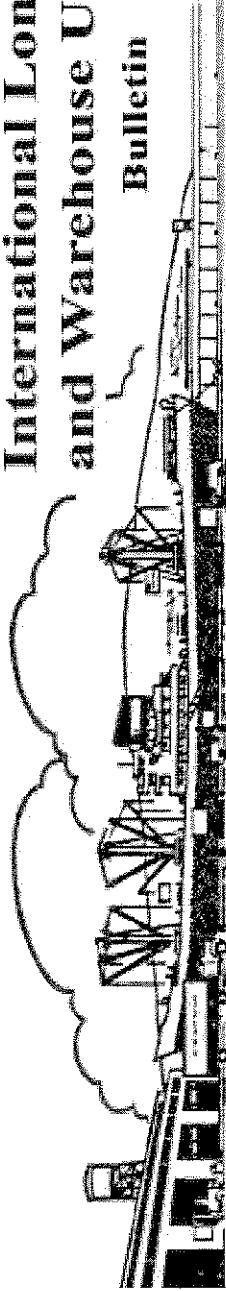

CESAR CHAVEZ PAID BIRTHDAY HOLIDAY

Cesar Chavez Birthday Wednesday, March 31, 2010 is a paid holiday. Only registered persons who have 800 qualifying hours in the prior payroll year (2009) and meet the availability requirements for at least two of the five days (exclusive of the holiday) Monday through Friday will receive a paid holiday for Cesar Chavez Birthday. This means you must work two of the days; Monday, March 29th, Tuesday, March 30th, Thursday, April 1st and Friday, April 2, 2010. Under the current contract one does not have to meet the availability requirements if you worked 1300 hours in the prior payroll year (2009) to receive Cesar Chavez Birthday holiday pay. Persons taking a vacation during the holiday week must report the vacation to the Records Clerk before April 2, 2010. Persons not receiving holiday pay because of illness, injury, jury duty, etc., must file a claim with the Records Clerk before May 21, 2010. The Cesar Chavez Birthday holiday pay will be paid on April 16, 2010 paycheck.
