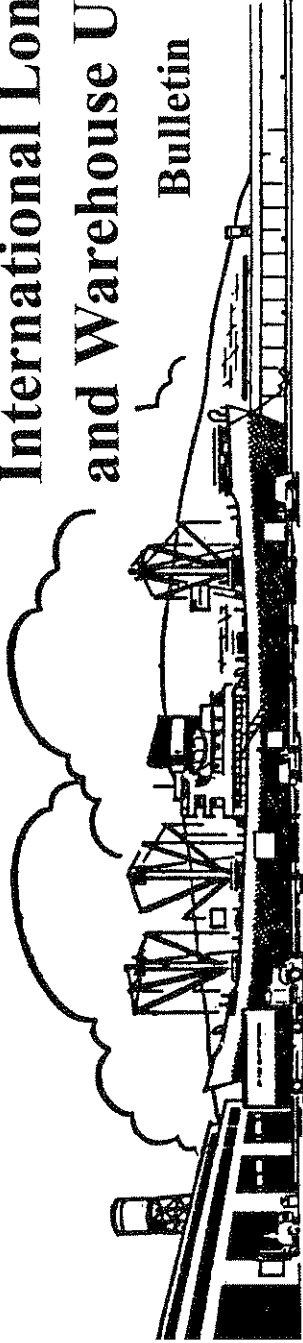

2010 FALL ELECTION

Nominations opened at the Stop Work Meeting on Thursday, August 5, 2010, for the following offices and committees:

Secretary/Treasurer (1), Labor Relations Representative (1), Health Benefits Representative (1), Trustee (1), Day Business Agent (1), Night Business Agent (1), Day Dispatchers (5), Night Dispatcher (1), Flex Dispatcher (1), Day Flex Dispatcher (1), Sgt-At-Arms (1), District Council (10), Political Action Committee (6), and Caucus Delegates (10). Nomination papers will be available at the dues office on Friday, August 6, 2010.

Nomination papers must be turned in no later than 10:00 a.m. on Saturday, September 4, 2010 at ILWU Local 13, 630 S. Centre Street, San Pedro, CA 90731.

Elections will be held on Tuesday, September 7th, Wednesday, September 8th and Thursday, September 9th. Run-off elections will be held on Tuesday, September 21st, Wednesday, September 22nd, and Thursday, September 23rd. Voting will take place at the ILWU Memorial Hall, 231 W. "C" Street, Wilmington, 90744. The polls will be open from 6:00 a.m. to 6:00 p.m. on each day.

ELIGIBILITY TO RUN FOR OFFICE

The 2010 Fall Election will be held under the current Constitution guidelines of Article IV, Section 1 and Article XI, Section 1, Sub-Section (b).

For a member to be considered in good standing, they shall have their dues, fines, and assessments paid in full every month, for twelve consecutive months prior to picking up a nomination paper. No nomination papers shall be issued to the member if this criterion has not been met. **NO EXCEPTIONS!!**

SCHOLARSHIP APPLICATIONS

Scholarship Applications for the ILWU Family Scholarship Program for the 2010 school year are now available at the Dispatch Hall or at the ILWU Local 13 Dues Office.

Any ILWU Local 13 member who has a son/daughter that graduated from high school in 2010 school year may apply. The deadline to turn in the application is Friday, September 10, 2010.

PIT CERTIFICATION

As you may already know on July 1, 2010 the PIT certifications for most equipment operators expired. Previously, anyone that had worked eight hours in the past three years was automatically recertified as agreed to by the Coast LRC(CLRC-9A-04 and CLRC-21-07). This year the Coast Committee informed the PMA that the Union was no longer agreeable to extend the PIT recertification procedures as contained in the previously stated minutes (CLRC-6-10).

The Employers have begun filing a large number of complaints against individuals that have taken a job for operating a piece of PIT equipment that they are no longer certified in. The Union is not ignoring these complaints, however we are taking the stance that in accordance with the agreement reached in 2001 (CLRC-6-01) that the PIT certification requirements are the sole responsibility of the Employer. If the Employer fails to perform their evaluations and do not recertify individuals, those individuals are not subject to disciplinary measures. As long as you have been trained under Section 9 of the PCLCD the Union is maintaining that you are eligible to take that job.

We will continue to keep you informed in future bulletins and at the membership meetings.
